FRSC Urges Motorists To Prioritise Safety As Rainy Season Intensifies

The Federal Road Safety Corps (FRSC) has urged motorists across the country to strictly adhere to road safety measures during the rainy season to reduce the risk of road crashes.

The Anambra State Sector Commander of the FRSC, Bridget Asekhanuo, gave the advice on Wednesday in Awka, warning that forecasts indicate heavier rainfall in the coming weeks.

She said motorists must ensure their vehicles are roadworthy before embarking on any journey, with particular attention to tyre condition, visibility, and other critical safety components.

According to her, tyres should have adequate tread depth and proper traction to maintain a firm grip on wet road surfaces, describing them as one of the most important safety features of any vehicle.

Asekhanuo noted that driving during

rainfall poses increased dangers due to reduced visibility, slippery roads, and other hazardous conditions that can easily lead to crashes if drivers fail to take necessary precautions.

She advised motorists to clean their windscreens and windows thoroughly and inspect essential safety equipment, including headlights, brake lights, tail lights, turn signals, windscreen wipers, and wiper blades, to ensure they are functioning properly.

Kaduna Gov Commissions Five Township Roads In Jaba LGA

Kaduna State Governor, Uba Sani, has commissioned five township roads in Kwoi, the headquarters of Jaba Local Government Area, alongside the strategic Kwoi–Gora Road, describing the projects as a major step toward addressing years of infrastructure deficit in the area.

Speaking during the commissioning ceremony, Governor Sani said the completion of the roads fulfilled a promise he made when he flagged off the projects in September 2025.

According to him, delivering on such commitments strengthens public confidence in government and demonstrates accountability.

The newly commissioned roads include Audu Tilo Road, Sabon Gari Road, Doctor Sani Road, Hospital Road and Kpop Ham Palace Road, in addition to the Kwoi–Gora Road.

The governor noted that Jaba Local Government had gone for more than two decades without the completion of

a single kilometre of road, describing the situation as a reflection of past infrastructural neglect.

He said the area was among 12 local government councils that received little attention in road development, adding that his administration is committed to ensuring equitable distribution of infrastructure projects across Kaduna State.

Governor Sani disclosed that his administration has initiated 150 road projects covering more than 1,355 kilometres across the state's 23 local government areas, with most of the projects already completed.

He explained that the projects are aimed at improving connectivity, expanding economic opportunities and ensuring that all communities benefit from democratic governance.

According to the governor, the newly completed roads will improve access to schools and healthcare facilities, ease the movement of farmers and traders.

Osun Pays Second Tranche Of Com'sation For Iwo Road Dualisation Project

The Osun State Government has commenced the second phase of compensation payments to property owners affected by the ongoing Iwo Township Road dualisation project, reaffirming its commitment to completing all outstanding payments despite financial challenges.

According to him, 67 beneficiaries received compensation in the latest phase, including Ansar-Ud-Deen Central Mosque, the Methodist Church and Right Time Kitchen.

NIWA To Upgrade Jetties, Phase Out Unsafe Boats Nationwide

The National Inland Waterways Authority (NIWA) has announced plans to establish additional jetties across the country, rehabilitate existing infrastructure, and phase out unsafe boats as part of efforts to improve safety and efficiency on Nigeria's inland waterways.

Chairman of the NIWA Governing Board, Barrister Mukhtar Shehu Shagari, disclosed this during a media briefing in Lagos following a facility tour of the Authority's projects and operations within the Lagos Area Office.

According to Shagari, the visit enabled the Board to assess ongoing operations, identify infrastructure gaps, and develop strategies to strengthen inland water transportation nationwide.

He said the Board had made budgetary provisions to rehabilitate dilapidated offices and jetties while constructing additional jetties, particularly in Lagos, to meet the growing demand for water transport.

"We have made provisions in our budget to address infrastructure challenges

across our offices and jetties nationwide. We want all NIWA facilities to be functional, presentable and capable of supporting efficient service delivery," Shagari said.

The Board Chairman expressed concern over the continued use of ageing and unsafe boats by some operators, describing many of the vessels currently in operation as outdated and unsuitable for modern water transportation.

He added that NIWA is collaborating with security agencies, including the Nigeria Police Force, to strengthen enforcement of water transport regulations, tackle the proliferation of illegal jetties, and improve compliance with safety standards.

Also speaking, the Managing Director of NIWA, Engr. Yusuf Gerie, said the Board's visit was aimed at gaining firsthand knowledge of activities within

the Lagos Area Office and identifying practical measures to improve operations across the country's inland waterways.

Gerie commended President Bola Ahmed Tinubu and the Minister of Marine and Blue Economy, Adegboyega Oyetola, for constituting what he described as a team of experienced professionals and technocrats to reposition the Authority and drive the Renewed Hope Agenda in the marine and blue economy sector.

In her welcome address, the Lagos Area Manager, Engr. Sarat Braimah, described Lagos as a strategic hub for inland water transportation in Nigeria and reaffirmed the office's commitment to promoting safety, regulatory compliance, operational efficiency, and infrastructure development on the nation's busiest waterways.

She expressed confidence that the Board's visit would further strengthen efforts to improve service delivery and enhance the Authority's overall performance.

High Ferry Fares Push Lagos Commuters Back To Road Transport

Many commuters in Lagos are abandoning inland water transportation for road travel as rising ferry fares make long-distance journeys increasingly unaffordable. Passengers who spoke on Tuesday at the Marina Jetty in CMS said the high cost of water transportation has discouraged many residents from using ferries, especially on longer routes such as CMS to Badagry and Ikorodu. According to the commuters, while the Apapa-CMS route remains popular because it helps passengers avoid the persistent traffic on Marine Bridge, fares on the route have risen from N500 to N700 and now N1,000. They noted that longer waterway trips have become significantly more expensive, with a one-way trip from CMS to Badagry costing about N10,000, while passengers travelling to Port Novo pay as much as N12,000. The commuters argued that such fares are considerably higher than road

transport costs, making road travel a more attractive option despite traffic congestion. Reacting to the concerns, Chairman of the Lagos chapter of the Association of Tourist Boat Operators and Water Transporters of Nigeria (ATBOWATON), Comrade Saheed Lawal, blamed the high fares on the soaring cost of petrol and the rising prices of spare parts. Lawal explained that operators also face challenges accessing fuel, noting that there is only one official fueling point for

NCAA Bans American Pilot, Grounds Aircraft Over Asaba Landing Incident

The Nigeria Civil Aviation Authority (NCAA) has barred the American pilot involved in the June 10 aviation incident at Asaba Airport from operating within Nigeria's airspace, while also suspending the aircraft's First Officer pending the conclusion of ongoing investigations.

The incident involved a Bombardier Challenger 601-3A operated by VMO Aero Limited with U.S. registration number N989BC, which reportedly landed on an uncompleted roadway in Asaba instead of the airport runway.

Director-General of the NCAA, Capt. Chris Najomo, disclosed the development on the sidelines of the Airport Business Summit in Lagos, stating that the regulatory authority had taken enforcement action after assuming responsibility for the regulatory aspect of the investigation from the Nigerian Safety Investigation Bureau (NSIB).

Najomo said the pilot-in-command had been removed from flight operations in Nigeria and prohibited from flying within the country's airspace. He added that the aircraft remains grounded, with its Permit for Non-Commercial Flight (PNCF)suspended. "The investigation is still ongoing. NSIB has handed the regulatory aspect to the NCAA, and we are conducting our own investigation," he said.

According to the NCAA boss, although the NSIB carried out the initial safety investigation, the matter has now entered the regulatory phase under the authority's jurisdiction.

He also revealed that the Department of State Services (DSS) had joined the investigation, underscoring the seriousness of the incident. "As we speak, the aircraft is grounded, the PNCF is suspended, and the pilots are suspended from flying in Nigeria's airspace until investigations are concluded. As a pilot with 45 years of experience, I will not mistake a road for a runway. We will also examine other possible motives," Najomo said.

He assured stakeholders and the travelling public that the NCAA would conduct a thorough and transparent investigation to establish the circumstances surrounding the incident and impose appropriate sanctions where necessary.

Speaking on the Airport Business Summit, Najomo described the event as an important platform for addressing key issues affecting Nigeria's aviation industry.

He noted that the NCAA would also review concerns raised by operators regarding monopoly and anti-competitive practices in the sector, stressing the authority's commitment to ensuring a level playing field,

Communities Seek Urgent Repairs On Asaba-Illah-Edo Fed Highway

Residents of Ugbolu, Illah, Ebu and other communities along the Asaba-Illah-Edo federal highway in Delta State have appealed to the Federal Government to urgently rehabilitate the road following its severe deterioration.

The residents said the road, which links Delta State with Edo and Kogi states and serves as a major gateway to the South-East and South-South regions, has become increasingly difficult to navigate, especially during the ongoing rainy season.

They called on President Bola Tinubu to declare a state of emergency on deteriorating federal roads across the country, noting that

the condition of the highway has continued to affect commuters, businesses and economic activities. Among those worst affected are civil servants, traders and other workers who reside in Ugbolu but commute daily to Asaba for work. They said the road has become a source of hardship due to frequent traffic disruptions and vehicle breakdowns.

The Delta State Government had previously rehabilitated the stretch of the road from Asaba to Ifeamanda Filling Station in Ugbolu during separate intervention works carried out last year and earlier this year. While that section has remained in good condition, residents said the remaining portions of the highway have deteriorated significantly.

Several sections between Ebu community, the entry point into Delta State from Edo State, and Ugbolu have reportedly failed, with one of the worst-hit portions in

Ugbolu becoming almost impassable. Heavy-duty vehicles are said to frequently break down on the damaged section, causing prolonged traffic congestion.

A resident, Mr. Kingston Omena, described the road as an economic lifeline that plays a critical role in regional trade and transportation.

According to him, the situation worsens whenever trucks break down, as smaller vehicles struggle to manoeuvre through the deep potholes, bringing traffic to a standstill.

He stressed that every day the road remains neglected increases transportation costs, disrupts businesses and places additional hardship on residents and commuters.

Commercial drivers and other road users also called for immediate palliative repairs, followed by a comprehensive reconstruction of the highway with proper drainage infrastructure to prevent further

deterioration.

Residents noted that persistent rainfall has worsened the condition of the road by washing away sections of the carriageway, creating deep gullies and making several parts unsafe for motorists.

Efforts to obtain comments from the Federal Controller of Works, Prince Oliseh, on plans to address the situation were unsuccessful, as he declined to comment.

They called on President Bola Tinubu to declare a state of emergency on deteriorating federal roads across the country, noting that the condition of the highway has continued to affect commuters, businesses and economic activities.
